 CTDOT commitment to designing and constructing a bicycle facility on Sigourney Street that accommodates bike access between Farmington and Capitol Avenues

 Mitigate the loss of a bicycle connection between Capitol Ave. and Farmington Ave. due to the 2013 roadway closure of Flower Street at the Amtrak and CT*fastrak* grade crossing for safety reasons



• Acquire all property/property rights necessary for the project.

### • Statutory References

- State of Connecticut: C.G.S. Section 13a-73 & 13a-98e
- Federal: Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as Amended.

### **Other Project Considerations**

- Utility coordination
- Environmental assessment
- Traffic control during construction
  - Pedestrian access and traffic will be maintained
  - No long-term road closures/detours



### **Other Project Considerations**



### Traffic control during construction

- Coordinate with emergency agencies and local property owners throughout project
- Maintain access to private driveways through all construction stages
- Maintain pedestrian access to Burns Elementary School at all times
- Typical work hours within roadway limited to 9 AM to 3 PM





## **Project Schedule & Cost**

- Schedule:
  - Bridge project construction scheduled for completion in 2023
  - Bike project
    - Design is 30% complete
    - Construction anticipated to start in 2024
    - Approximate duration 1 to 2 construction seasons
- Project Cost:
  - Approximately \$4,000,000 to \$6,000,000
  - 100% FTA funded
