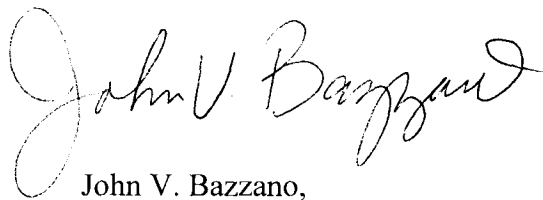

The Office of Women's Health has awarded the Ryan White Program a one time funding of \$3,000 for year 2009-2010; and

WHEREAS, Once received, these funds will be allocated to fund a subcontract with Central Area Health and Education Center (AHEC), a provider in the North end of Hartford who provides Outpatient Ambulatory Care to individuals living with HIV/AIDS. These women are hard to reach and engage for care; now, therefore, be it

RESOLVED, That the Mayor and Court of Common Council do hereby authorize the application for and acceptance of funding in the approximate amount of \$3,000 from the Federal U.S. Department of Health and Human Services (DHHS) under the Part A of the Ryan White and to subcontract with the Central Area Health and Education Center (AHEC), to provide woman's health services to HIV/AIDS affected women who receive HIV infectious disease care at the Burgdorf Clinic; and be it further

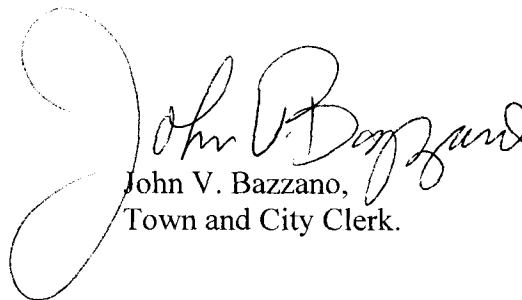

This is to certify that at a meeting of the Court of Common Council, October 13, 2009, the following RESOLUTION was passed.

WHEREAS, The Greater Hartford TGA (Transitional Grant Area) covering Hartford, Middlesex, and Tolland Counties had 3,742 persons living with HIV/AIDS in 2008 and has received funding each year since 1996 including \$4,527,381 for the 2009 Federal entitlement and supplemental financial assistance under Part A of the Ryan White Treatment Modernization Act of 2006; and

WHEREAS, To continue to procure these funds the City of Hartford must submit an application each year to the Federal U.S. Department of Health and Human Services (DHHS), through its Health Resources and Services Administration (HRSA); and

WHEREAS, In September 2008, the City of Hartford applied for \$3,790,748 to enable not only the City of Hartford but fifty-seven towns in Hartford, Middlesex, and Tolland Counties to better meet the needs of residents affected by HIV/AIDS for the next year; and

WHEREAS, The City of Hartford's Health and Human Services Department has successfully addressed these disparities via services provided through the Ryan White Program, and has received grant funding by the Federal U.S. Department of Health and Human Services (HHS), through its Health Resources and Services Administration (HRSA) to continue to provide Regional services; and

WHEREAS, Once received, these funds will be allocated to fund subcontracts, administered by the City of Hartford's Department of Finance's Purchasing Division, to the various City and State health providers which provide medical care and support services for low-income families and individuals in the Greater Hartford Metro Region; now, therefore, be it

RESOLVED, That the Mayor and Court of Common Council do hereby authorize the application for and acceptance of funding in the approximate amount of \$4,527,381 from the U.S. Department of Health and Human Services (DHHS) under the Part A of the Ryan White Treatment Modernization Act of 2006, to develop and implement the Ryan White Part A Program for persons living with HIV/AIDS for the period of March 1, 2010 through February 28, 2011; and be it further

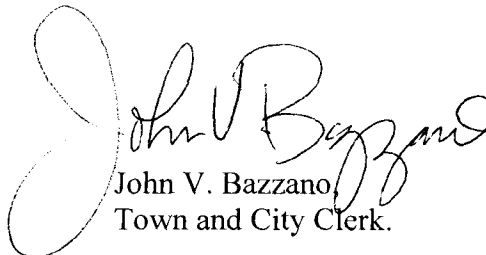

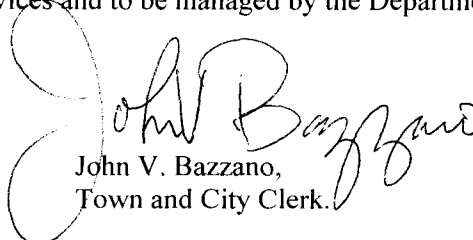

WHEREAS, The City of Hartford was successful in securing Federal Stimulus (ARRA) Funds in 2009 for the Pope Commons Streetscape Project pursuant to a competitive solicitation for "shovel ready" construction projects; and

WHEREAS, This project will create streetscape improvements on Park Street from Park Terrace to Pope Park Highway #4, using these Federal Stimulus (ARRA) Funds; and

WHEREAS, The Federal Government will provide the State of Connecticut Department of Transportation (DOT) funds in the amount of approximately \$3.6 million for this project that will cover 100 percent of construction and inspection costs, which in turn will be provided to the City as reimbursement for eligible costs; and

WHEREAS, The City's financial match for this project will consist of the funding the City has already encumbered, primarily in the prior fiscal year, that facilitated the engineering design and thus rendered the project in "shovel ready" status at the time of the competitive process; and

WHEREAS, The project will consist of new brick paver sidewalks, decorative lighting, raised center median, storm drainage, new traffic signal, pavement, and other typical streetscape elements; and

WHEREAS, The City of Hartford will be responsible for the bidding, project administration, and coordination of the project; and

WHEREAS, The City of Hartford will be reimbursed for 100 percent of the cost of an engineering consultant that will be retained to perform construction inspection and direct administration of the project; and

WHEREAS, The City of Hartford must commit to providing long term maintenance, repair, and operation of the completed project; and

WHEREAS, The City must enter into a formal agreement with the State of Connecticut as a condition of receiving the grant; now, therefore, be it

RESOLVED, That the Mayor or the Mayor's designee, is hereby authorized to sign an agreement between the State of Connecticut and the City Of Hartford for the Construction, Inspection, and Maintenance of the Pope Commons Streetscape Project utilizing Federal Funds From ARRA Federal Stimulus, State Project No. 63-660, and be it further

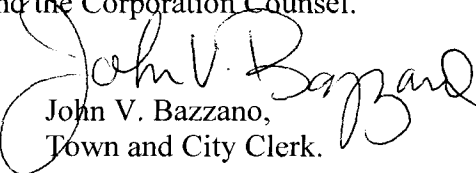

WHEREAS, Since April 2002 the Department of Health and Human Services has worked collaboratively with other health departments and health organizations to develop a comprehensive pandemic influenza response plan; now, therefore, be it

RESOLVED, That the Mayor and Court of Common Council do hereby authorize the Department of Health and Human Services to accept funding in the amount of approximately \$53,338.00 from the State of Connecticut's Department of Public Health to provide various services to operate the Public Health Emergency Response to H1N1 Mass Vaccination Program for the period of July 31, 2009 through July 30, 2010; and be it further

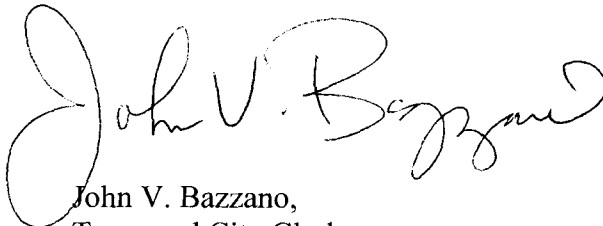

- The City will participate in any media interviews that are scheduled at a time agreeable to the spokespersons; now, therefore, be it

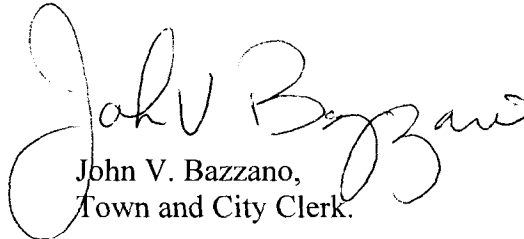

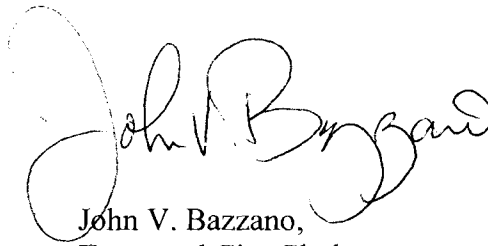
WHEREAS, These projects lead up to Main Street, but there have not been any public discussions thus far about project that would revitalize Hartford's main thoroughfare, Main Street; and
