This is to certify that at a meeting of the Court of Common Council, March 8, 2010, the following RESOLUTION was passed.

WHEREAS, Childhood Lead Poisoning is one of the most common and preventable public health problems today, and has shown through research to have an impact on social services, criminal justice and education programs and lead is neurotoxic and particularly harmful to the developing nervous systems of fetuses and young children; and

WHEREAS, Public health practitioners have set an objective to eliminate childhood lead poisoning; and

WHEREAS, The Connecticut Association of Directors of Health, Inc. (CADH) have set an objective to explore a different approach to produce more equitable health outcomes for Connecticut residents. By recognizing the need for a coordinated effort to address this goal, incorporating partnerships with area partners; and

WHEREAS, CADH is working in collaboration with the State Department of Public Health to facilitate the distribution of funding to other local health departments in achieving this goal; and

WHEREAS, The State Department of Public Health has made available approximately \$47,071 to the City of Hartford to continue its efforts to reduce the cases of childhood lead poisoning for the period of July 1, 2009 through June 30, 2010; now, therefore, be it

RESOLVED, The Mayor and Court of Common Council do hereby authorize the Department of Health and Human Services to apply for and receive funding from the State of Connecticut Department of Public Health (DPH), through the Connecticut Association of Directors of Health, Inc. (CADH) in the approximate amount of \$47,071

to continue its childhood lead poisoning prevention efforts for the period of July 1, 2009 through June 30, 2010; and be it further

RESOLVED, That the Mayor is hereby authorized to make, execute and approve on behalf of the City of Hartford, any and all contracts, sub-contracts and amendments until otherwise ordered by the appropriate authority; and be it further

RESOLVED, That the Mayor is hereby further authorized to execute any and all manner of other documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interests of the city in order to effectuate the above transaction; and be it further
