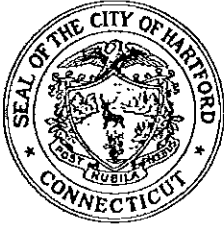

This is to certify that at a meeting of the Court of Common Council, January 10, 2011, the following RESOLUTION was passed.

Whereas, The State of Connecticut Board of Education and Services for the Blind (BESB) Business Enterprise Program operates a program through which federal, state and municipal governments secure vending machines for their buildings under the authority of Connecticut General Statute 10-303 and the Randolph Sheppard Act which was enacted by Congress in 1936, and

Whereas, The purpose and intent of the program is to provide greater economic opportunities for persons who are blind and, in most cases, the revenue from such vending machines is returned to the BESB for use in the Business Enterprise Program, and

Whereas, State law allows for revenues from vending machines located in recreation centers and schools to be used for programs that benefit students and also requires that a separate account be set up and maintained for these revenues, and

Whereas, BESB provides and services vending machines at Parker Memorial and Pope Park Recreation Centers, now, therefore, be it

Resolved, That the Court of Common Council does hereby authorize creation of a separate account to deposit the revenue from the vending machines at Parker Memorial and Pope Park Recreation Centers for the period of July 1, 2010 through June 30, 2011, and be it further

Resolved, That, at the request of the State of Connecticut, the City of Hartford hereby adopts as its policy to support the Non-Discrimination Agreements and Warranties required under Connecticut General Statute § 4a-60(a) (1) and § 4a-60a (a) (1), as amended in State of

Connecticut Public Act 07-245 and Sections 9(a) (1) and 10(a) (1) of Public Act 07-142, as those statutes may be amended from time to time.

This is to certify that at a meeting of the Court of Common Council, January 10, 2011, the following RESOLUTION was passed.

Whereas, Recent H1N1 influenza outbreaks have brought to light the need for a coordinated response, including mass vaccinations, to this and other infectious diseases, by the City of Hartford and its community health partners, using guidelines established by the Centers for Disease Control (CDC) and the CT Department of Public Health (DPH), and

Whereas, The CDC, through DPH, has established a Cooperative Agreement Award for Public Health Emergency Readiness, for the purpose of upgrading State and local public health jurisdictions' preparedness for and response to outbreaks of infectious disease and other public health threats and emergencies, and

Whereas, DPH has been notified by the CDC that Public Health Emergency Readiness (PHER)/H1N1 grant funding is being made available and that the City of Hartford is eligible to apply for up to \$100,000 to develop and update plans for its mass vaccine dispensing area, now therefore, be it

Resolved, That the Mayor is hereby authorized to apply for and accept funding in the approximate amount of \$100,000 from the CT Department of Public Health for operation of the Public Health Emergency Readiness to H1N1 mass vaccination program by the Department of Health and Human Services, for the period of August 10, 2010 through August 09, 2011; and be it further

Resolved, That the City of Hartford hereby adopts, as its policy, to support the Non-Discrimination Agreements and Warranties required under Connecticut General Statutes § 4a-60(a) (1) and § 4a-60a (a) (1), as amended in State of Connecticut Public Act 07-245 and Sections 9(a) (1) and 10(a) (1) of Public Act 07-142, as those statutes may be amended from time to time; and be it further

Whereas, Pursuant to Chapters 133 and 300a of the Connecticut General Statutes, the Commissioner of the State Department of Social Services is authorized to extend financial assistance to Municipalities & Human Resource Development Agencies; and

Whereas, The Connecticut Department of Social Services has made available Emergency Shelter Services (ESS) funding of approximately \$935,296 for the period October 1, 2010 to September 30, 2012 to subsidize the operation of McKinney Shelter; and

Whereas, The City is cognizant of the conditions and prerequisites for State Assistance imposed by Chapters 133 and 300a of the Connecticut General Statutes and recognizes the responsibility for the provisions of local grant-in-aid to the extent that they are necessary and required to operate City programs; now, therefore, be it

Resolved, That the Court of Common Council authorizes the City to apply for and accept a grant of approximately \$935,296 from the State of Connecticut Department of Social Services; and be it further

Resolved, That the Mayor is hereby authorized to execute and file the above stated application with the Connecticut Department of Social Services and to execute a Grant Action Request with the State of Connecticut for State financial assistance to operate the McKinney Shelter for the period of October 1, 2010 to September 30, 2012; and be it further



Whereas, The North End Senior Center provides services, support and recreation activities for elderly Hartford residents; and


Whereas, Among the activities offered is an annual Super Bowl party hosted at the center; and
