WHEREAS, The City of Hartford is currently undertaking a much needed street improvement project on Pratt Street which will include street reconstruction, new lighting, paving and landscaping; and

WHEREAS, The total cost of the Pratt Street Improvement Project will be \$980,000 and \$581,613 has been identified as available within CIP streetscape and design accounts; and

WHEREAS, \$398,387 is available in the Unassigned Balance Account as a result of a payment made by Aetna Life Insurance Company to the City in 2008; now, therefore, be it

**RESOLVED,** That the Mayor is hereby authorized to reallocate \$398,387.10 from the Unassigned Balance Account to the Capital Improvement Fund for implementation of the Pratt Street Improvement Project; and be it further

**RESOLVED,** That the Mayor is authorized to execute any and all manner of other documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interests of the City in order to effectuate the above transaction; and be it further

**RESOLVED,** That no person or entity shall be entitled to rely on, or otherwise claim any benefit by reason of this resolution should the Mayor fail to execute the aforementioned agreement or other documents, or to take any of the aforesaid actions; and be it further

This is to certify that at a meeting of the Court of Common Council, May 11, 2015 the following RESOLUTION was passed.

WHEREAS, The Connecticut Department of Economic and Community Development (DECD) has offered a Grant in the amount of \$3,750,000 to the City of Hartford; and

WHEREAS, Grant funds will be used for two projects: \$1,500,000 for a new police substation at the northeast corner of Coventry and Holcomb Streets and \$2,250,000 to continue streetscape improvements on portions of Wethersfield, Franklin and Maple Avenues; and

WHEREAS, The Grant requires matching funds in the amount of \$1,100,000 for both grants and such funds are available in current City Cost Centers W9519 and W9511; now, therefore, be it

**RESOLVED,** That the Hartford Court of Common Council hereby authorizes the Mayor of the City of Hartford to apply for and accept a grant of \$3,750,000 from the Connecticut Department of Economic and Community Development, and to enter into a contract with DECD to accept \$3,750,000 for the purpose of constructing the police substation on Coventry Street and streetscape improvements on Wethersfield, Franklin and Maple Avenues; and be it further

**RESOLVED,** That the Mayor is authorized to accept any further sums as may be additionally awarded by the grantor under the same program, for the same authorized contract period, and for the same purposes; and be it further

**RESOLVED,** That the Mayor is hereby authorized to execute any and all manner of documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interests of the City in order to receive, contract and expend the DECD funds; and be it further

**RESOLVED,** That no person or entity shall be entitled to rely on, or otherwise claim any benefit by reason of this resolution should the Mayor fail to execute the aforementioned agreements or other documents, or to take any of the aforementioned actions; and be it further

**RESOLVED,** That all approvals and authorizations provided hereby are contingent upon, and only shall be effective on and by means of, the Mayor executing such agreements and documents, and taking such actions, all of which shall be, in form and substance, acceptable to the Mayor and the Corporation Counsel.

This is to certify that at a meeting of the Court of Common Council, May 11, 2015 the following RESOLUTION was passed.

WHEREAS, The City uses aerial imagery for a number of purposes, including the Geographic Information System and the Assessor's property records; and

WHEREAS, Pictometry International Corporation's aerial and oblique imagery and their patented imaging process produces geo-referenced, high-resolution oblique (at an angle, 3D-like view) and ortho (straight down) images used in the City Assessor's Office in conjunction with the Patriot Properties Computer Aided Mass Appraisal software, as well as with the City's current Geographic Information Systems (GIS) software, and no other vendor provides the ability to integrate oblique imagery directly into the above mentioned software currently used by the City Assessor and GIS staff; and

WHEREAS, The City's current three year-contract with Pictometry will expire in June of this year and MetroHartford Information Services and the Procurement Division have recommended that the City enter into a new three-year aerial imaging contract with Pictometry International, at a total cost of \$66,402; and

WHEREAS, The cost of the contract will be shared by Metro Hartford Information Services, the City Assessor's Office (Finance), and the Office of Emergency Services and Telecommunications; now, therefore, be it

RESOLVED, That the Mayor is hereby authorized to enter into a three year contract, for the period July 1, 2015 through June 30, 2018, with Pictometry International Corporation, in the total amount of \$66,402, for provision of aerial ortho and oblique imagery; and be it further

RESOLVED, That the Mayor is further authorized to execute any and all manner of other documents and to take such other actions as he, the Corporation Counsel, and Metro Hartford

Information Services may deem appropriate and in the best interests of the City in order to effectuate the above transaction; and be it further

RESOLVED, That no person or entity shall be entitled to rely on, or otherwise claim any benefit by reason of this resolution should the Mayor fail to execute the aforementioned agreement or other documents, or to take any of the aforesaid actions; and be it further

This is to certify that at a meeting of the Court of Common Council, May 11, 2015 the following RESOLUTION was passed.

WHEREAS, Evidence from around the country identifies many benefits from the use of body-worn cameras by local police departments, including but not limited to

- significant reductions in the number of incidents involving the use of force;
- significant reductions in the number of complaints filed against police officers;
- an increase in the ability, quickly and without dispute, to resolve non-meritorious complaints against police officers;
- the ability to improve training by using video of actual incidents in training programs;
   and
- improved documentation of crime-scene and accident-scene evidence; and

WHEREAS, At a meeting of the Quality of Life and Public Safety Committee on October 21, 2014, the Chief of Police indicated that the Police Department was working on developing a plan to test the use of body-worn cameras in Hartford; and

WHEREAS, No such plan has been presented to the Court of Common Council (the "Council") or implemented by the Police Department; and

WHEREAS, The Council believes it is in the interest of both the residents of the City and the police force of the City to implement a policy requiring the use of body-worn cameras by police officers; now, therefore, be it

**RESOLVED,** That the Mayor and Chief of Police are requested to develop a plan to equip the Hartford police force with body-worn cameras (the "Plan"); and be it further

**RESOLVED,** That the Mayor and Chief of Police are requested to report on the Plan to the Council no later than March 15, 2015 and such report shall include the status of implementation efforts and should specifically identify any obstacles to the preparation and implementation of the Plan; and be it further

**RESOLVED,** That the Council expresses its view that the City of Hartford should take advantage of the recently announced federal program to provide financial support for equipping local police forces with body-worn cameras.
