This is to certify that at a special meeting of the Court of Common Council, June 29, 2017, the following SUBSTITUTE RESOLUTION was passed.

WHEREAS, The City of Hartford must complete and submit to the U.S. Department of Housing and Urban Development (HUD) its Year Three Annual Action Plan for the period July 1, 2017 through June 30, 2018, in order to receive entitlement funds under the Community Development Block Grant (CDBG), Home Investment Partnership (HOME), Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) programs; and

WHEREAS, The Year Three Annual Action Plan outlines the City's intended use of approximately \$7.2 million in HUD entitlement funds, prior year resources and unspent prior year funds, including \$4,082,252 in CDBG, \$282,368 in ESG, \$1,162,598 in HOPWA, and \$1,638,518 in HOME dollars for activities and programs that support specific priority needs and objectives identified in the City of Hartford's Five Year Consolidated Community Development Plan (2015-2020); and

WHEREAS, The Year Three Annual Action Plan was developed according to HUD's approved Citizen Participation Plan, which included two public hearings, several community meetings and a 30-day comment period that solicited citizen feedback on the needs of the community in areas such as Housing, Economic Development, and Public Service; now, therefore, be it

RESOLVED, That the following activities and allocations of funds are approved and incorporated into the Year Three Annual Action Plan:

RESOLVED, That the Court of Common Council authorizes the Mayor to submit the Year Three Annual Action Plan to HUD for approval and release of funds; and be it further

RESOLVED, That the Court of Common Council designates the Mayor as the City's authorized representative and further authorizes him to take all steps necessary to implement the Year Three Annual Action Plan; and be it further

RESOLVED, That the Mayor is authorized to accept such further sums as may be additionally awarded by the grantor under the same program, for the same authorized contract period, and for the same purposes; and be it further

RESOLVED, That the Mayor is authorized to execute any and all manner of other documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interests of the City in order to receive, contract and expend the above referenced grant funds; and be it further

RESOLVED, That the Mayor is authorized in the event of any reduction by HUD in the award(s) of Entitlement Funds in CDBG, HOME, ESG, and/or HOPWA, from the amounts on which the herein authorized allocations are based, to take all steps necessary to further implementation of the Year Three Annual Action Plan, first by ensuring all planned non-public service municipal functions continue without resort to increased expenditure of general funds, and then by reduction of awards proportionally, across all subrecipients within the subject program (e.g., CDBG, HOPWA, etc.), for the duration of the affected fiscal year or until all funds under each subrecipient contract, or any extension(s) thereof, have been expended in furtherance of the Year Three Annual Action Plan; and be it further

RESOLVED, That no person or entity shall be entitled to rely on, or otherwise claim any benefit by reason of this resolution should the Mayor fail to execute the aforementioned agreement or other documents, or to take any of the aforesaid actions; and be it further

RESOLVED, That all approvals and authorizations provided hereby are contingent upon, and only shall be effective on and by means of, the Mayor executing such agreements and documents, reallocating unexpended funds between existing line items within a 25% variance according to the City's evolving priority needs and objectives, and taking such actions, all of which shall be, in form and substance, acceptable to the Mayor and the Corporation Counsel.

This is to certify that at a special meeting of the Court of Common Council, June 29, 2017, the following RESOLUTION was passed.

WHEREAS, It is projected that the Court of Common Council, Corporation Counsel, Public Works Department, Health and Human Services Department, Benefits and Insurances account, and Debt Service account will incur expenditure overruns in Fiscal Year 2017; and

WHEREAS, In accordance with Chapter X Section 7(a) of the City of Hartford Charter, the Mayor has recommended the transfer of \$4,014,000 within the General fund to cover these projected overruns; and

WHEREAS, Funds are projected to be available in the unencumbered appropriation balances in the Fiscal Year 2017 General Fund Budget, in the Mayor's Office, Office of the Chief Operating Officer, Communications Office, Finance Department, Human Resources Department, Office of Management, Budget & Grants, Families, Children, Youth & Recreation Department, Fire Department, Police Department, Department of Development Services, and other General Fund departments for transfer to the departments noted above; now, therefore, be it

RESOLVED, That the Mayor is hereby authorized to make the following transfers in the FY 2017 General Fund Budget:

- Transfer \$4,014,000 from Mayor, Chief Operating Officer, Communications, Finance, Human Resources, Management, Budget & Grants, Families, Children, Youth & Recreation, Fire, Police, Development Services, and any other General Fund Departmental appropriations with available unencumbered appropriation balances, and
- Transfer \$14,000 to Court of Common Council,

- Transfer \$75,000 to Corporation Counsel,
- Transfer \$420,000 to Public Works Department,
- Transfer \$1,050,000 to Health and Human Services Department,
- Transfer \$635,000 to Benefits and Insurances in the Sundry Account, and

• Transfer \$1,820,000 to Debt Service in the Sundry Account.
