This is to certify that at a meeting of the Court of Common Council, November 25, 2019, the following RESOLUTION was passed.

WHEREAS, The City of Hartford (the "City") has made a substantial financial investment in the restoration of Keney Park Golf Course and Goodwin Park Golf Course (the "Golf Courses"); and

WHEREAS, The City has taken the steps necessary to provide its residents and visitors a high quality golf experience at the Golf Courses, and the adoption of reasonable fees is essential to the successful financial operation of the Golf Courses; and

WHEREAS, The Department of Public Works (the "DPW") and its consultant on golf operations - the Connecticut Section of the Professional Golfers Association - have completed an analysis of fees charged by the other municipal golf courses in the region, which shows that the golf fees proposed by the DPW are similar to the average fee charged in the region; and

WHEREAS, A review of golf pricing at other golf venues open to public play has shown there is a need to adjust pricing in a dynamic fashion in order to attract individuals due to seasonal, weather, time-of-day, day-of-week and competition between golf venues; and

WHEREAS, The City's Department of Public Works, its consultant on golf operations, the Connecticut Section, PGA of America, Inc., and the City's Golf Professional, Peter Seaman, have completed an analysis of the revenue impacts of allowing dynamic pricing of rates and fees; and

WHEREAS, The analysis of the revenue impacts of allowing dynamic pricing of rates and fees shows a potential increase in revenue without a decrease in course use during historically peak use periods; and

WHEREAS, The City's Golf Course Oversight Commission, at a Special Meeting on June

26, 2019, reviewed and unanimously approved recommending that the Court of Common Council amend the rates and fees in a manner that allows dynamic pricing; and

WHEREAS, The City's Golf Course Oversight Commission, at a Special Meeting on November 6, 2019, reviewed and unanimously approved a resolution recommending to the Court of Common Council the adoption of the fees as proposed by DPW; now, therefore, be it

RESOLVED, That the City's Court of Common Council, in accordance with Chapter IV, Section 2(e) of the City's Charter and Sections 26-4 and 2-330.64(f) of the City's Municipal Code, hereby adopts the maximum rates as set forth below:

WHEREAS, The City of Hartford executed a Parking License Agreement with Rensselaer Hartford Graduate Center, Inc. effective August 1, 2019 to provide up to eighty parking spaces in its garage at 275 Windsor Street for use by the Hartford Board of Education and, in particular, the Capital Preparatory Magnet School's staff; and

WHEREAS, The term of the agreement is one year, from August 1, 2019 through July 31, 2020, with an option to extend through July 31, 2022, at the discretion of the Board of Education; now, therefore be it

RESOLVED, That the Council hereby approves the Agreement as a multi-year arrangement, in accordance with the applicable provisions of the agreement, so that, subject to other relevant provisions in the agreement, the agreement shall have a multi-year term that will run through July 31, 2022; and be it further

WHEREAS, At its meeting on May 28, 2019 the Court of Common Council awarded funds in the amount of \$28,165.40 to ImmaCare through the City's HUD-funded Emergency Solutions Grant (ESG) program for FY 2019-20; and

WHEREAS, ImmaCare is undergoing extensive renovation and will not be reopened until Spring 2020, which reduces the amount of ESG funding needed by ImmaCare to \$7,041, about a quarter of the total funding from the FY 2019-20 allocation; and

WHEREAS, The City seeks to provide additional financial support for the rapid rehousing, rapid exit and/or diversion activities conducted by the Coordinated Access Network and serving Hartford's homeless population in connection with the City's warming center services, with the aims of improving housing outcomes for homeless individuals; now, therefore, be it

RESOLVED, That City of Hartford FY 2019-20 Emergency Solutions Grant funding be reallocated from ImmaCare in the amount of \$21,124.40 to Journey Home, as lead organization operating the CAN, to provide for additional rapid rehousing, rapid exit and diversion activities in connection with Hartford's FY19-20 warming center operations; and be it further

RESOLVED, That the Mayor is authorized to execute any and all manner of other documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interests of the City in order to reallocate, contract and expend the above referenced grant funds; and be it further

This is to certify that at a meeting of the Court of Common Council, November 25, 2019, the following RESOLUTION was passed AS AMENDED.

WHEREAS, Shelbourne Properties and its affiliates (collectively "Shelbourne") own two existing office buildings at 20 Church St and 100 Pearl Street and gained majority interest control over the property known as Talcott Plaza (comprised of three parcels known as 1006 Main St., 30 Talcott St. And 36-70 Talcott St.); and

WHEREAS, Shelbourne Properties appealed their real property tax assessment for the 2016 Grand List on the properties at 20 Church St. And 100 Pearl St. And owed in excess of three million dollars in back taxes on the properties known as Talcott Plaza; and

WHEREAS, In settlement of tax appeal litigation, and pursuant to approval of the Court of Common Council, the City entered into an Agreement (August 31, 2018) in which real property taxes on 20 Church and 100 Pearl were fixed for a five year period; and

WHEREAS, Said Agreement included provisions for the repayment of back taxes on Talcott Plaza, the demolition and clearing of the site known as Talcott Garage by December 31, 2019, to be paid out of a \$10 Million development commitment made by Shelbourne Properties in the downtown area; and

WHEREAS, Shelbourne has conducted engineering studies that support the possibility of saving the Talcott Plaza Garage rather than demolishing it; and

WHEREAS, the City has determined that amending the original Agreement to allow for additional time in which to determine the best approach to Talcott Plaza is in the public interest; and

WHEREAS, Shelbourne Properties has agreed to increase its commitment of \$10 million for downtown investment to; now therefore, be it

RESOLVED, That the Court of Common Council hereby approves amending the original Settlement Agreement to extend the time by which Shelbourne properties can evaluate whether to demolish or repair the Talcott Parking Garage to June 30, 2019; and be it further

RESOLVED, That said extension be granted contingent upon the December 29th payment in full of approximately 1.5 million dollars

RESOLVED, That Shelbourne will, as part of this amended Agreement, commit additional funding for development projects in the downtown area (above the \$10 million already committed); and be it further

RESOLVED, That the Mayor is authorized to execute any and all manner of documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interests of the City in order to effectuate the above transaction; and be it further

WHEREAS, The State of Connecticut Department of Transportation ("DOT") requires five (5) temporary construction easements on portions of land in Hartford (collectively the "Easements," and each a numbered "Easement") owned by the City of Hartford (the "City") relative to DOT's rehabilitation of Bridge No. 00980B I-84 TR 826 (the "Bridge") over the Connecticut River (the "Project"); and

WHEREAS, Easement One and Easement Two, together, consist of approximately 2.13 acres, and are for the purpose of providing access from Leibert Road to the Bridge; and

WHEREAS, Easement Three consists of approximately 799 square feet, and is for the purpose of providing access from Easement Two to the Bridge; and

WHEREAS, Easement Four and Easement Five, together, consist of approximately 6,317 square feet, and are for the purpose of reconstructing and widening a paved pedestrian trail and installing a temporary sedimentation control system; and
