WHEREAS, The State of Connecticut is seeking communities with a health collaborative focused on improving the health of its residents by establishing Health Enhancement Communities (HEC); and

WHEREAS, HEC grants funds will be been provided to the City by the Connecticut Department of Health, through its Office of Health Strategy, and such funds are managed by the Hartford Department of Health & Human Services; and

WHEREAS, The City will submit a grant application for funding of \$35,000 under the HEC Pre-Planning for the period of November 1, 2019 through January 31, 28, 2020; and

WHEREAS, These funds will be allocated through a contract to the United Way of Central and Northeastern Connecticut, the fiscal agent of the North Hartford Triple Aim Collaborative, to provide services in support of the grant; now, therefore, be it

RESOLVED, That the Court of Common Council hereby authorizes the Mayor to apply for and accept approximately \$35,000 in grant funding from the Connecticut Department of Health-Office of Health Strategy for the period of November 1, 2019 through January 31, 28, 2020; and be it further

RESOLVED, That the Mayor is authorized to accept such further sums as may be additionally awarded by the grantor under the same program, for the same authorized contract period, and for the same purposes; and be it further

WHEREAS, The City of Hartford's Tree Advisory Commission has drafted the 2018-2019 Hartford Tree Plan in compliance with the City of Hartford's Tree Ordinance; and

WHEREAS, This Plan was developed over a two-year period in collaboration with critical municipal, state, and community stakeholders; and

WHEREAS, The Plan seeks to maintain the health of Hartford's urban forest, ensure public safety, increase the City's tree canopy to at least 35% coverage, reduce the urban heat island effect through target plantings in identified urban heat islands, increase tree plantings aimed at energy savings, reduce storm water run-off through target plantings, improve air quality through forest management and careful selection of new trees, design and implement an environmental stewardship program for Hartford schools, City of Hartford employees, and Hartford citizens, and become an urban forestry model for other cities; and

WHEREAS, The Plan combines two reports specified in the Hartford Tree Ordinance – the "State of the Forest" report called for under Section 28-156(h), and the Master Tree Plan called for under Section 28-154 of the Hartford Municipal Code; now, therefore, be it

RESOLVED, That the Court of Common Council hereby endorses the 2018-2019 Hartford Tree Plan as drafted by the Tree Advisory Commission and supports the implementation of its long-term goals and objectives for the City's urban forest canopy.

WHEREAS, The State of Connecticut Department of Public Health (DPH) through the Family Wellness Healthy Start (FWHS) grant, has made available funding to improve women's health, improve family health and wellness to low-income high-risk prenatal women and their families and to increase adequate prenatal care and inter-conception care, provide health education, assessments and screenings to pregnant women and their families; and

WHEREAS, The City of Hartford's Department of Health and Human Services was awarded \$75,000.00 by the DPH to implement the HFWS the first year, which covers May 30, 2019 through March 31, 2020. All future years funding will be based on satisfactory programmatic progress and the availability of funds; and

WHEREAS, The FWHS will focus on residents (primarily African American and Hispanic Americans) living in Hartford; now, therefore, be it

RESOLVED, That the Hartford Court of Common Council hereby authorizes the Mayor of the City of Hartford to accept \$75,000.00 in HFWS grant funding to the City of Hartford, Department of Health and Human Services for the first year of the HFWS, which cover May 30, 2019 through March 31, 2020; and be it further

RESOLVED, That the Mayor is authorized to accept such further sums as may be additionally awarded by the grantor under the same program, for the five-year grant funding period May 30, 2019 through March 31, 2024, and for the same purposes; and be it further

RESOLVED, That the Council hereby authorizes the City to execute yearly contracts for the five-year grant funding period of May 30, 2019 through March 31, 2024; and be it further

RESOLVED, That the Mayor is hereby authorized to execute any and all manner of documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interests of the City in order to receive, contract, and expend the above referenced grant funds; and be it further

WHEREAS, Bloomberg Philanthropies and What Works Cities created the Providence Talks Replication Cohort to expand the Providence Talks model in cities across the nation and to help cities use evidence-based practices rooted in data to effectively tackle pressing challenges; and

WHEREAS, A growing body of research shows that language and vocabulary exposure are among the most important factors in healthy early childhood development, including future reading abilities; and

WHEREAS, The City of Hartford ("the City") has been invited to apply to be part of the Providence Talks Replication Cohort, a cohort of peer cities, to develop a Hartford-specific implementation of the Providence Talks model, which emphasizes language and vocabulary exposure; and

WHEREAS, If the City's implementation plan is accepted, the City will receive a planning grant of \$50,000 and will be eligible for up to \$400,000 in additional funding over three years, plus additional pro bono technical assistance and material support provided by Bloomberg Philanthropies, Results for America, What Works Cities, LENA, and other partners; and

WHEREAS, The City, with its partner, the Village for Families and Children, seeks to implement a professional development program for providers carrying out home visiting initiatives in Hartford and at Early Learning Centers throughout the City, and additionally provide language training, coaching, and support for parents in the City, to increase children's exposure to language and vocabulary; now, therefore, be it

RESOLVED, That the Mayor is hereby authorized to apply for and accept a grant in the amount of up to \$450,000 from Bloomberg Philanthropies and What Works Cities; and be it further

RESOLVED, That the Mayor is authorized to accept such further sums and support as may be additionally awarded by the grantors and their partners under the same program, for the same authorized contract period and any immediate extension thereof, and for the same purposes, including technical assistance, materials and support provided by Bloomberg Philanthropies, Results for America, What Works Cities, and LENA; and be it further

RESOLVED, That the Mayor is hereby authorized by contract or otherwise to partner with such stakeholders, community groups, residents, businesses and other organizations as may be deemed by the mayor to be necessary to carry out activities under this award, including the Village for Families and Children; and be it further

This is to certify that at a meeting of the Court of Common Council, October 15, 2019, the following RESOLUTION was passed.

WHEREAS, Westbrook Housing Phase II, is a proposed 5.14 -acre development which will include a total of 60 units consisting of 45 affordable residential units and 15 market rate residential units on a parcel land located at 144 Mark Twain Drive, officially known as 1550 Albany Avenue, (the "Property"), owned by the Housing Authority of the City of Hartford (HACH) and proposed by Penrose, LLC. Westbrook II Housing, LLC will lease the land from the HACH for a term of 65 years. Construction is to commence in the year 2020.

WHEREAS, Westbrook II Housing, LLC, has submitted an application for a new tax abatement which documents the need for tax relief and the Tax Abatement Committee has recommended such an agreement, now, therefore, be it

RESOLVED, That the Mayor is hereby authorized to enter into a Tax Abatement Agreement with Westbrook II Housing, LLC for the Property, subject to the following conditions:

- 1. The term of the Agreement shall not exceed Fifteen (15) years from the date on which the first temporary certificate of occupancy (TCO) or permanent certificate of occupancy (CO) whichever is earlier issued on the property.
- 2. Developer will pay prorated real estate tax on any improvements that receives TCO or CO for the fiscal year such is issued during the construction phase.
- 3. Developer will pay taxes according to the following for the 45 affordable units:

• Year 1-15 Eight Hundred Dollars (\$800.00) per unit, per year for a total of \$36,000.00 per year.

After year 4, the unabated taxes shall be subject to a 2% increase per unit per year in each year the city upwardly adjusts the Grand Levy (e.g., the amount of revenue raised by property taxes in a fiscal year), with the 2% increases being effective July 1st of each year as applicable. Years 8-15 increases in the unabated taxes due to an increase in the Grand Levy will become permanent and accumulative.

- 4. During the term of the abatement, all 45 units are to remain affordable as prescribed by the Low Income Housing Tax Credit Program. In the absence of a Deed or Mortgage Instrument defining affordability, the City of Hartford will determine affordability utilizing an established, transparent methodology
- 5. Owner shall comply with all applicable laws, regulations, ordinances and codes of the United States, the State of Connecticut and the City of Hartford in the operation and management of the Premises.
- 6. The tax abatement agreement shall be non-assignable, non-transferable without written consent of the Mayor of the City of Hartford.
- 7. Notwithstanding anything to the contrary in this Agreement, City agrees that this Agreement shall automatically transfer and inure to the benefit of any party succeeding to the interest of the Owner under this Agreement. as a result of a foreclosure of a mortgage encumbering the Property or a transfer in lieu of foreclosure or realizing on a pledge or security interest of the equity interests in such Owner (including, without limitation, replacement of the managing member of such Owner), and if such transferee is a bank or other financial institution, such rights shall automatically transfer and inure to the benefit of any party immediately succeeding to the interest of such bank or other financial institution.
- 8. Upon any future sale or refinance, during the term of the abatement payment shall be made to the City of 10% of the net sales proceeds, or equity recapture, not to exceed the total of abated taxes.
- 9. During construction, Developer will comply with Article XII, Section 2-680 of the Hartford Municipal Code, Hartford Affirmative Action Plan / Equal Employment Opportunity which requires developer to set aside 15% of the total construction project cost for certified Minority & Women Business Enterprises, assure no less than 15% of total project work hours by trade will be worked by minority and or women trade workers, no less than 30% if total project work hours to be worked by Hartford Residents.
- 10. In the case of default, the City of Hartford shall retain the right to cancel the agreement and its remedy may include the payment of abated taxes.
