- The Annual Action Plan addresses the intended use of HUD supported entitlement grant funds under the four formula programs covered in the City’s Five-Year Consolidated Plan – **Community Development Block Grant (CDBG), Housing Opportunities for Persons with AIDS (HOPWA), Emergency Solutions Grant (ESG), and the Housing Investment Partnerships Program (HOME)**.

All allocations are subject to adoption by the Hartford Court of Common Council and release of funds from HUD.
