This is to certify that at a meeting of the Court of Common Council, May 10, 2010 the following SUBSTITUTE RESOLUTION was passed.

WHEREAS, No later than May 15, 2010, the City must complete and submit to the U.S. Department of Housing and Urban Development (HUD) a new Year One Annual Action Plan to the Five-Year Consolidated Community Development Plan in order for the City to continue receiving HUD entitlement funds, and in order for the City and the community to be eligible to apply for and receive other HUD competitive grant funds; and

WHEREAS, The Year One Annual Action Plan addresses the City's intended use of entitlement grant funds along with allocations for activities for the Fiscal Year July 1, 2010 through June 30, 2011 under the Community Development Block Grant (CDBG), Home Investment Partnership Program (HOME), Emergency Shelter Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) Programs; and

WHEREAS, The goal the Year One Annual Action Plan is to create a city of growth and opportunity for all by making each of the City's seventeen neighborhoods a better place to live, work, conduct business, and engage in recreation; and

WHEREAS, The 30 day public comment period for the Year One Annual Action Plan is conducted from April 2, 2010, through May 2, 2010; now, therefore, be it

RESOLVED, That the Court of Common Council authorizes the Mayor to submit the Year One Annual Action Plan to HUD by May 15, 2010 for approval; and be it further

RESOLVED, That the Mayor upon approval by HUD, is authorized to implement and carry out all activities in accordance with the adopted Plan, including negotiating and entering into all necessary agreements, and reallocating unexpended funds between existing line items within a twenty-five percent (25%) variance should the City's evolving priority needs and objectives within the fiscal year necessitate such action. In the event the final HUD entitlement amounts the City receives are modified from the estimated amounts, the Mayor shall be authorized to make adjustments to sub-



recipient grant awards based on the percentage differential of the actual entitlement amounts; and be it further

RESOLVED, That the Mayor is hereby authorized to execute any and all manner of other documents and to take such other actions as he and the Corporation Counsel may deem appropriate and in the best interests of the City in order to effectuate the above transaction; and be it further

RESOLVED, That no person or entity shall be entitled to rely on, or otherwise claim any benefit by reason of this resolution should the Mayor fail to execute the aforementioned agreements or other documents, or to take any of the other aforesaid actions, and be it further

RESOLVED, That all approvals and authorizations provided hereby are contingent upon, and only shall be effective on and by means of, the Mayor executing such agreements and documents, and taking such actions, all of which shall be, in form and substance, acceptable to the Mayor and the Corporation Counsel.

This is to certify that at a recessed meeting of the Court of Common Council, May 10, 2010, the following RESOLUTION was passed.

WHEREAS, A driving goal under U.S. immigration law is family unification and the ability of families and individuals to reside legally in the U.S., engaging fully in our country's rich civil traditions and form of government; and,

WHEREAS, The Court of Common Council celebrates and respects all immigrant groups and all families, including those of same-sex gay and lesbian partners; and,

WHEREAS, Current U.S. immigration law discriminates against a U.S. citizen or lawful permanent resident and his or her foreign-born partner by not allowing the sponsorship of the foreign partner for immigration benefits, although an opposite-sex couple would have the right to do so; and,

WHEREAS, This form of discrimination and unfair treatment under the law has devastating and life-altering consequences for same-sex partners; and,

WHEREAS, The inability to sponsor a same-sex partner leaves the couple with the following limited options: a) Choose to remain in a costly long-distance international relationship; b) Choose to live abroad in the foreign partner's country, if allowable; c) Seek a visa, independent of the partnership, for the foreign-born partner, creating a limited duration of legal stay; d) Choose to allow the foreign-born partner to remain undocumented or allow a visa to lapse, creating daily uncertainty and fear of deportation; or, e) Terminate the relationship; and,

WHEREAS, The limited legal options for same-sex partners to keep their relationship unified exacts an enormous emotional, financial, and mental toll, disproportionate to opposite-sex couples in bi-national relationships; and,

WHEREAS, Beyond the personal challenges to same-sex couples, the City of Hartford and the entire country risk a great loss of talent should the foreign partner and/or the U.S. citizen or lawful permanent resident be forced to depart the U.S. to keep the relationship whole in another country; and,

WHEREAS, Currently pending in the United States Congress is the Uniting American Families Act (H.R. 1024/S.424), reintroduced on February 12, 2009, by Representative Jerrold Nadler (D-NY-8) and Senator Patrick Leahy (D-VT). The purpose of this bill is "to amend the Immigration and Nationality Act to eliminate discrimination in the immigration laws by permitting permanent partners of United States citizens and lawful permanent residents to obtain lawful permanent resident status in the same manner as spouses of citizens and lawful permanent residents and to penalize immigration fraud in connection with permanent partnerships"; and,

WHEREAS, The Uniting American Families Act would allow same-sex relationships to be treated no differently from opposite sex relationships and all legal requirements of qualifying under the statute and proving the good faith nature of their relationship would remain; and,


WHEREAS, The Uniting American Families Act would bring U.S. immigration law in line with the 21 other countries that already recognize same sex partnerships for immigration purposes: Australia, Austria, Belgium, Brazil, Canada, Czech Republic, Denmark, Finland, France, Germany, Iceland, Israel, the Netherlands, New Zealand, Norway, Portugal, South Africa, Spain, Sweden, Switzerland, and the United Kingdom; and,

WHEREAS, The City of Hartford fully supports the measures of Congress to allow gay and lesbian partners to access immigration benefits in an equal and fair manner, equivalent to opposite sex partners who currently enjoy such legal rights;

RESOLVED, The Court of Common Council does hereby express our strong support for the passage of the Uniting American Families Act, or other laws that will end discrimination for bi-national same-sex partners under the immigration laws and will allow gay and lesbian residents of the City of Hartford fair and equal access to immigration benefits through their permanent partnerships.







WHEREAS, On April 23, 2010, the Governor of Arizona signed Arizona State Senate Bill 1070, the Support Our Law Enforcement and Safe Neighborhoods Act, into law. This reactionary piece of legislation is a step backwards from the American tradition of expanding rights and freedoms of those who reside here; and

WHEREAS, The City of Hartford celebrates its diversity and seeks to promote an environment in which its residents feel comfortable regardless of their origin, race, ethnicity, religion, sexual orientation, gender or any other personal attribute. This is evidenced by the passage of an ordinance in the summer of 2008 that ensures that the City shall provide services to residents regardless of immigration status; and

WHEREAS, Arizona's SB 1070 requires police that when practicable, to detain people they "reasonably suspect" are in the country without authorization; allows the police to charge immigrants with a state crime for not carrying immigration documents and creates a private right of action to sue cities upon belief that the local government has a policy or practice that restricts immigration law enforcement; and

WHEREAS, The contents of this law will inevitably lead to racial profiling, jeopardize public safety and create a wedge between law enforcement and ethnic communities; and

WHEREAS, Numerous elected officials through the country, including the Mayor of Phoenix, and hundreds of thousands of individuals on May 1, 2010 came out publically against Arizona's actions; now, therefore, be it


