# Annual Report

## on Allegations and Results

---

Hartford city ordinance requires that the Civilian Police Review Board (“CPRB” or “the Board”) produce an annual report to Court of Common Council and the mayor’s office.<sup>1</sup> This report is submitted by the Inspector General, on behalf of the Civilian Police Review Board, to the mayor and council members in order to detail the numbers and types of allegations received by the Board and make that information available to the public.

## Background

The Civilian Police Review Board was established to provide civilian oversight to allegations of police misconduct in Hartford. In 2020, the Court of Common Council updated the ordinance governing the CPRB, changing a number of procedures, creating the officer of Inspector General and providing the board with subpoena power, in addition to other changes. A new Chair took over as head of the CPRB in March 2021 and a permanent Inspector General started in February of 2022. As of March 2021, there were 170 cases backlogged in the CPRB system and the board was using a dated case management system.

Hartford, Conn., Rev. Ordinances Part II, Ch. 2, Art. V. § 2-196(e) requires that the CPRB provide a report the Court of Common Council. The Report is required to detail:

- 1) The type and number of complaints filed,
- 2) The number and identity of police officer(s) complained against and the number and identity of police officer(s) and members of the police department against whom multiple complaints were received, and the disposition of the complaints, and
- 3) The identity of police officers with either
  - i. more than two complaints in any twelve-month span or
  - ii. more than five total complaints during the previous ten years.
- 4) The dollar value, if any, of settlements ordered and/or paid arising out of the citizen complaints, provided such disclosure does not violate a confidentiality agreement.

After an extensive review of the CPRB’s backlogged cases and infrastructure, the Inspector General determined that Council and the Mayor had not received an annual report for 2019, 2020 or 2021. On May 20, 2022, the Inspector General provided a preliminary report to Council and the Mayor’s office, explaining that the report was only provisional because:

- 1) The CPRB had not reached a “disposition” on all the complaints from the missing years and the Board was attempting to clear the backlog.
- 2) The complaints that had reached disposition had not all been recorded in the CPRB’s database.
- 3) The Board was currently working with an outdated electronic database and awaiting bids for a new database system.

The Board cleared the backlog in September 2022. It then worked with an outside vendor, iSight/CaseIQ, to develop a new case management system. This report is the culmination of those efforts, detailing the allegations and results for the missing years and intervening time.
